

In arbitration, there is no judge or jury and review is limited. 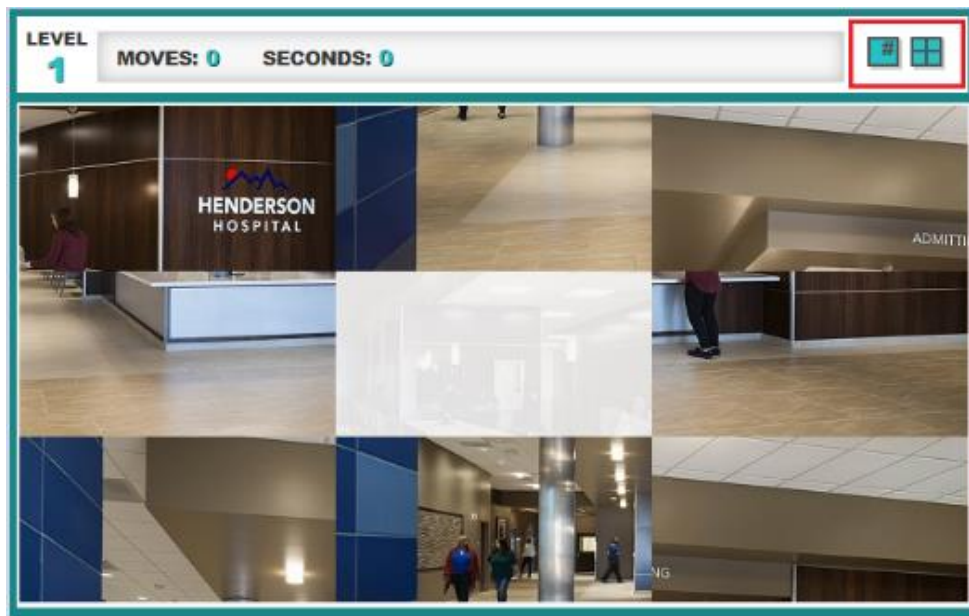
Architecture for Health Showcase Puzzle Instructions

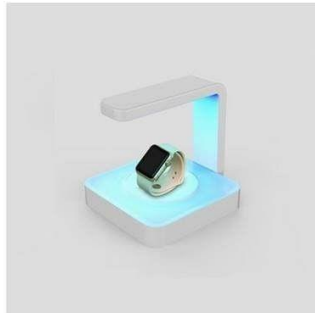
