The PRIMA Annual Conference offers more than 55 educational sessions including risk financing, risk mitigation, claims management, safety, leadership strategies, benefits and human resources, pool, enterprise risk management and workers' compensation. Topics will cover the latest trends and changes that will affect all risk managers and will feature late-breaking hot topics that capture the latest dynamics occurring within the public risk management profession.

**APPLICATION DEADLINE: Monday, March 4, 2019**

**Scholarship Benefits:**

Each scholarship recipient receives \$1,500 in financial assistance to be applied to a complimentary registration to the PRIMA's Annual Conference plus four nights of lodging and a \$250 stipend.

**Criteria:**

Applicants will be judged based on the following criteria:

- Must be current risk management professional who performs job responsibilities including, but limited to; insurance procurement, claims and incident handling, risk mitigation, claims management, emergency management (such as natural disasters, flooding and fire) safety operations, legal, health and/or benefits for a tribal organization;
- Demonstrated financial need;
- Must include resume.

You do not have to be a PRIMA member to apply. Only one individual per organization may receive a scholarship in a single year.

**Application Procedure:**

- Applicants must complete the Tribal Scholarship Application on page 2. The application must include supporting documentation.

**Completed application *MUST* be received by Monday, March 4, 2019.**  
**Applications received after this date will be rejected.**
